Capital markets are maturing rapidly. This year has seen the birth of the corporate bond market and the listing of the first major bank. Next year will bring the first listing of a state-owned bank. What other developments can be expected?

The financial services sector is the largest and most important component of the capital markets in Vietnam. So far growth has been strong and share prices have performed extremely well. With state banks preparing to list in the next two years, what will happen to this industry as it meets the challenges of greater competition? What are legal and accounting updates?

The real estate sector is one of the most dynamic growth areas in the Vietnamese economy, with strong demographics and shortages in all key categories leading to many exciting investment opportunities.
